

Boxholm City Council Meeting Feb 13th, 2025

A regular meeting of the Boxholm City Council was held on Feb 13th, 2025 at 7:00 pm at the Boxholm City Hall with Mayor Sue Shreve. Council members present: Veva Teeters, Paul Frazier, Brandon Wendt, Robyn Dodson. Absent - Victoria Helling

Motion by Frazier, second by Dodson to approve the agenda as presented. Ayes: Teeters, Frazier, Wendt, Dodson Opposed: None.

Motion by Teeters second by Wendt to approve the minutes of the last meeting. Ayes: Teeters, Frazier, Wendt, Dodson Opposed: None.

Motion by Dodson second by Frazier to approve the treasurer's report and the bills. Ayes: Teeters, Frazier, Wendt, Dodson Opposed: None.

Sheriff Godzicki and 28E agreement- Sheriff Godzicki came to discuss the County Sheriff's expired 28E agreement. Motion to renew the 28E agreement between the Boone County Sheriff and Boxholm made by Dodson, second by Tetters. Ayes: Teeters, Frazier, Wendt, Dodson Opposed: None. The cost is for \$25 per person based on the 2020 census and will expire July 1, 2030.

Pod- Motion to allow Mandy Skogland to have a storage pod in the alley until no later than April 1st, 2025.

Driveway purchase- Discussion on the driveway contract was held. Contract tabled.

Sewer Rate- After discussion about the current rates and expenses for the sewer department the Council will prepare to raise the sewer rates by \$2. Clerk will prepare a Resolution, and post the notices for a rate increase.
